Scottish Older People's Assembly (SOPA)

The SOPA 2024 AGM was held on 29 January in the Mackintosh at the Willow Tea Rooms in Sauchiehall Street, Glasgow. The branch membership secretary and administrator attended this event.

All attendees introduced themselves and read the minutes of the AGM of 6 December 2022, held in Edinburgh via Zoom. The trustees' report was issued and the vice-chair gave an overview of SOPA's work during 2021/22 as detailed in the trustees report.

The annual accounts for 2021/22 were issued by SOPA's financial examiner and approved by the trustees on November 2022.



The results of the election of trustees were approved, with all officers willing to serve another year.

An interesting and comprehensive presentation explained in great detail, with computer slides, SOPA's three-year plan (2024-27) including an impact assessment plan, with organised working groups.

This focused on our individual journeys, with memory and fitness activities for all ages – such as grandparents working with the younger generation, hobbies or interests, and outdoor activities.

Examples are given of local groups and organisations you can join to stay as physically and mentally active as possible and avoid loneliness and isolation.

Eight tablets and cases were handed to the deputy head of the school by Michael Kirby.
